PAHALGAM TERROR ATTACK

Massive crackdown in Kashmir post-massacre

AUTHORITIES IN KASHMIR have launched a massive crackdown on terrorists and their sympathisers in the aftermath of the Pahalgam terror attack, razing homes of ultras, raiding their safe havens and detaining hundreds of overground workers for questioning, officials said on Saturday.

Houses of five terrorists or their associates have been demolished in the past 48 hours with officials saying similar action will be taken against others involved in terror activities.

Raids were carried out at more than 60 places on Saturday in Srinagar to dismantle the terrorist ecosystem, a K Police spokesperson said.

In Anantnag district, search operations are being carried out round-the-clock as security forces step up vigilance. Mobile vehicle checkpoints have been put up across the district to monitor any suspicious movement, officials said.

The security forces are going after the known terrorist associates and their sympathisers across the length and breadth of the valley to deterrence against any Pahalgam-like attacks, officials said. Terrorists on Tuesday opened fire in Baisaran, a popular tourist spot in the upper reaches of Pahalgam district, killing 26 people, mostly holidaymakers from other states, an incident that has sparked India-Pakistan tensions, with Prime Minister Narendra Modi warning that the killers would be pursued "to the ends of the earth". Mysterious blasts blew up the houses of two active terrorists: Aadil Thoker in the Bijnbehara area of Anantnag district and Asif Sheikh in the Tral area of

Pakistan offers to join 'transparent, neutral' probe in Pahalgam strike

PAKISTAN ON SATURDAY offered to join a "neutral and transparent" probe into the Pahalgam terrorist attack that killed 26 people.

"The recent tragedy in Pahalgam is yet another example game, which must come to a grinding halt. Continuing with its role as a responsible country, Pakistan is open to participating in any neutral, transparent and credible investigation," Prime Minister Shehbaz Sharif said.

Talking about the suspension of the Indus Water Treaty by India, Sharif said any attempt to stop, reduce or divert the flow of water belonging to Pakistan would be responded to with full force

and might. Sharif threatened to use all options if the water of its share was stopped by India. He said the entire nation stood by the armed forces of Pakistan to safeguard every inch of the homeland. "Our valiant armed forces are capable and remain fully prepared to defend the country's sovereignty and its territorial integrity against any misadventure," he said.

"Peace is our preference but must not be construed as our weakness," he said. —PTI

Goyal has said that terror attacks like the one in Pahalgam would continue to disturb the nation as long as all 140 crore Indians regard patriotism and nationalism as their "paramount dharma".

He emphasised that such acts would never break India's spirit.

Speaking to reporters here on Friday, Goyal asserted that the conviction of the people would ensure the resumption of tourism in Kashmir soon, and pilgrims will continue their Amaravathi Yatra. He said India's rising global stature was troubling certain forces.

"These incidents represent the desperate last efforts of those powers, it is an unbearable attack, but we will not spare anyone," the minister added.

"As long as 140 crore Indians consider patriotism and nationalism as paramount dharma, such types of incidents will continue to disturb our country. However, India has enough strength to give a befitting response," the minister said.

Goyal said, "Just as we are rapidly eliminating nationalism, we will similarly defeat terrorism. India's strength and determination are unshakable." When asked about Pakistani nationals overstaying their visas in India, Goyal said, "We have already announced and informed them to leave the country. No one will be allowed to stay here illegally." Addressing concerns that the attack might affect tourism in Kashmir, Goyal added, "The people of Bharat have the power,

courage, and confidence. Tourism will resume soon, pilgrims will continue their Amaravathi Yatra, and Kashmir will remain firmly on the path of progress. No one can stop it." 26 persons were killed when terrorists sprayed bullets on them at a popular meadow in Pahalgam. And the anguish and anger over the brutal killings, India announced a slew of diplomatic measures, including suspending the Indus Water Treaty, against Pakistan.

UNSC condemns killings in J&K

THE UNSC HAS "condemned in the strongest terms" the terrorist attack in J&K, stressing that those responsible should be held accountable and the organisers and sponsors of this "repulsive act" should be brought to justice.

The 15-nation council issued a press statement in which it said, "We stressed that those responsible for these killings should be held accountable, and urged all States, in

accordance with their obligations under international law and relevant Security Council resolutions, to cooperate actively with all relevant authorities in this regard."

France is President of the Council for the month of April and the press statement was issued by Council President Permanent Representative of France to the UN Ambassador Jerome Bonnafant. US had floated the draft statement, which was then discussed by

Council members. The members of the Security Council expressed their deepest sympathy and condolences to the families of the victims and to the governments of India and Nepal, and wished for a speedy and full recovery to those who were injured. In the April 22 terror attack in Pahalgam, 25 Indians and one Nepali citizen were killed. The victims were mostly tourists from all across India. —PTI



Five killed, over 700 hurt in Iran explosion

A MASSIVE EXPLOSION and fire at a port in southern Iran has killed five people, authorities said Saturday. Babak Mahmoudi, the head of the country's rescue organisation, made the announcement on state television. Over others have been injured in the blast at the Shahid Rajaei port just outside of Bandar Abbas, a major facility for container shipments for the Islamic Republic that handles some 80 million tonnes of goods a year.

Social media videos showed black billowing smoke after the blast. Others showed glass blown out of buildings kms away from the epicenter of the explosion. State media footage showed the injured crowding into at least one hospital, with ambulances arriving as medics rushed one person by a stretcher. Authorities offered no cause for the explosion hours later, though videos suggested whatever ignited at the port was highly combustible.

Industrial accidents happen in Iran, particularly at ageing oil facilities that struggle for access to parts under international sanctions. But Iranian state TV specifically ruled out any energy infrastructure as causing or being damaged in the blast.

State TV reported there had been a building collapse caused by the explosion. The interior ministry said it launched an investigation into the incident. Shahid Rajaei port in Hormozgan province is some 1,050 kms south-east of Iran's capital, Tehran.
